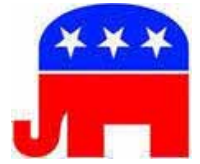


# Prince William County Republican Committee

**Qualifications for participation in the Republican Party:** All legal and qualified Prince William County voters under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party, and who, if requested, express in open meeting either orally or in writing as may be required their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia and the Prince William County Republican Party in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts. Check other membership requirements on the Republican Party of Virginia's website at [www.RPV.org](http://www.RPV.org). Click "About RPV" and then "Party Plan".

**Election to Membership:** The Committee must approve Membership either at the biennial county convention or subsequent meeting. Dues for the biennium are \$50. Members elected before April 2011 may elect to pay \$25 at the time of application and \$25 on or before April 30, 2011. Members who fail to pay the second installment shall lose all their membership privileges. Members elected on or after April 30, 2011 shall pay \$25 at the time of application. All memberships expire on the date of the biennium convention in 2012. Membership fees are not refundable.

**Attendance Requirements:** As a member of the Committee you are expected to attend meetings of the Committee and participate in its activities. According to the Rules of the Republican Party of Virginia, missing three (3) consecutive meetings of the Committee without providing a proxy causes membership, including voting privileges, to lapse. Reinstatement does not require an additional fee.
